EXEMPTIONS

Exemption from Part 2 (Classification) and Part 5 (Means of Containment) of the Transportation of Dangerous Goods Regulations, as adopted by the Dangerous Goods Transportation and Handling Regulation, for the road transportation of waste filters that may contain hydrocarbons and gas from various sites throughout Alberta to an approved facility for disposal or treatment.

CONDITIONS

1. The dangerous goods have not been chemically tested and classified in accordance with Part 2 of the Regulations.
2. The large means of containment or transport vehicles transporting the dangerous goods shall display the placards and UN number in accordance with Part 4 of the Regulations and as shown in the Appendix to Part 4 for Class 9, miscellaneous dangerous goods. The UN Number shall be UN3077.
3. In addition to the permit, all consignments shall be accompanied by a document that specifies:

- the name of the carrier

- the address of the carrier
- the name of the consignor
- the address of the consignor
- the words UN3077, "ENVIRONMENTALLY HAZARDOUS SUBSTANCES, SOLID, N.O.S. (WASTE FILTERS MAY CONTAIN HYDROCARBONS AND GAS), CLASS 9, PACKING GROUP III"
- the total quantity of dangerous goods in kilograms at all times
- the date
- the 24 hour telephone number

4. For the purposes of emergency response and reporting requirements, the consignment should be treated as:

"UN3077, ENVIRONMENTALLY HAZARDOUS SUBSTANCES, SOLID, N.O.S. (WASTE FILTERS MAY CONTAIN HYDROCARBONS AND GAS), CLASS 9, PACKING GROUP III"

5. The containers used for shipping the dangerous goods shall be designed, constructed and stowed so that under normal conditions of transport:

(a) there will be no release of the dangerous goods;

(b) there will be no evolution or chemical reaction which, under normal conditions of transport, shall impair the effectiveness of the container or induce heat generated or spontaneous combustion.


6. A copy of this permit shall accompany each load and the driver shall be made aware of the permit location.

7. This permit exempts the permit holder from only those Part(s) or Section(s) of the Regulations identified above. To qualify for the exemptions shown, all permit conditions must be adhered to and all remaining applicable provisions of the Act and Regulations or other related legislation must be complied with.

8. If the conditions of this permit are not met, the permit holder shall be in full compliance with the Act and Regulations and the permit shall no longer be applicable.
9. This permit is valid only in Alberta.
10. All those involved with the handling, offering for transport, and transporting the dangerous goods identified shall be trained and certified in accordance with Part 6 of the Regulations.
