INTRODUCTION

EnCana Corporation is proposing to develop its Deep Panuke gas prospect located offshore Nova Scotia. The Project Field Center which will contain all of the main facilities, will be located approximately 250 km southeast of Halifax, approximately 47 km west of Sable Island and in 44 metres water depth.

Development of the Project is subject to regulatory approval and EnCana Corporation project sanction.

The Deep Panuke Project will generate important activity and provide significant opportunities within Nova Scotia and Canada. In recognition of this, EnCana Corporation is committed to using and encouraging capable and competitive Nova Scotian and Canadian companies for the provision of the high quality goods and services required in these activities.

SCOPE OF WORK

EnCana Corporation seeks qualified, experienced parties to acquire, process, document and analyze/interpret geophysical and geotechnical data for the Deep Panuke Field Centre location, wellsite locations, export pipeline route options and flowline/umbilical routes.

The geophysical survey Scope of Work shall include the provision of a vessel(s) and crew equipped with multibeam, sidescan sonar, magnetometer, sub bottom profiler and high resolution seismic survey equipment. A ROV will also be required to perform investigations on the existing well conductors which may include a video survey and a positioning survey (i.e. check verticality of the 30-inch conductors). The geotechnical field program Scope of Work consists of obtaining grab samples and CPT measurements at predetermined locations along the export pipeline and flowline/umbilical routes (5 metre depth).

Interested parties must include provision of all necessary equipment and personnel to complete the entire scope of work.

It is anticipated that the Work will be awarded post Project Sanction, and will commence no earlier than November 1, 2007.

GENERAL REQUIREMENTS

EOI respondents are required to have an implemented Quality Management System that complies with the requirement of the ISO-9000 series of Standards and Safety Management Systems(s). Respondents are also notified that the Work carried out on the Deep Panuke Project shall comply fully with Canada Nova Scotia Offshore Petroleum Board Regulations.

Respondents must be qualified and demonstrate that they have suitable processes and capability to complete the scope of work. They must also be able to demonstrate previous experience on similar projects.

Interested firms are asked to demonstrate their capabilities and experience via a formal response to this Expression of Interest and submit a brief Company profile, contact details, potential vessel(s) description, availability, key personnel and a summary of related experience including local Nova Scotia capabilities.

Additionally, information regarding proposed vessel(s), including technical capability and availability should be submitted.

EnCana is committed to providing opportunities for Nova Scotian and Canadian companies through employment, procurement and contracting on an internationally competitive basis with full and fair opportunity for Canadians, and first consideration to Nova Scotians where competitive on a best value basis.

Pre-qualified companies will be required to complete a Canada-Nova Scotia Benefits questionnaire, and demonstrate their commitment to and compliance with EnCana's requirements regarding Canada-Nova Scotia Benefits, during the tender process.

EnCana will select qualified bidders using the respondents to this Expression of Interest as a guide.

Expressions of Interest must be received on or before **27 September 2007 1:00 pm Halifax local time**.
