Introduction

Encana Corporation is the owner and operator of the Deep Panuke natural gas project in Nova Scotia's offshore. The project involves the installation of the facilities required to produce natural gas from the Deep Panuke field, located approximately 175 kilometres offshore Nova Scotia. Natural gas from Deep Panuke will be processed offshore and transported, via subsea pipeline, to Goldboro, Nova Scotia for further transport to market via the Maritimes & Northeast Pipeline.

Encana Corporation is in the process of disposing of surplus air winches from its Deep Panuke Subsea Installation Program. Companies interested to bid on Encana's surplus air winches are required to express their interest prior to the closing date indicated above. The surplus air winches will be available for viewing and sale in Halifax Regional Municipality (HRM), Nova Scotia, Canada. The surplus air winches will be sold "AS IS, WHERE IS". Loading of equipment will be the responsibility of the Encana. The successful Purchaser will be required to make payment by certified cheque, prior to taking delivery.
